## RULES AND REGULATIONS

**FAILURE TO EXHIBIT:** If any organization having signed this form for exhibition space fails to exhibit for any reason of the organisation's own, then in that circumstance the exhibitor will not be released from the contract and shall be liable to pay full amount stated in the contract. These terms cannot be varied under any circumstances.

**LIMITATION OF LIABILITY:** The organizers shall not in any event be held responsible for any restriction or conditions which prevent, the construction, erection, completion, alteration or dismantling of stands, the entry, sitting or removal of exhibits or for the failure of services or amenities provided by the hall landlords or other third parties.

**EXHIBITOR'S INSURANCE:** Exhibitors shall make sure that they are fully covered by insurance including, but not restricted to all risks on their property, exhibits or articles of any kind, public liability and comprehensive protection against any loss or damage caused by and under any circumstance whatsoever whether by reason of fire, water, theft, accident or any other cause. The Exhibitor shall insure against indemnity and not hold the organizer responsible with respect to cost, claims, demands and expenses to which the organizer may in any way be subject as a result of any loss or inquiry arising to any person (Including the members or the public or the organizer staff, agents or contractors) property howsoever caused, as a result of any act or default of the exhibitors their servants, agents or contractor or invitee. If the organizer so demands the exhibitors shall provide proof to the organizer that the exhibitor has adequate insurance cover. Exhibitors must ensure that their temporary staff, the staff servants, agents or contractors are insured against claims for worker's compensation. The period for which such insurance shall be maintained shall run from the time the Exhibitor or any of this servants agents or contractors first enters the exhibition grounds, and to continue until he/she has vacated the exhibition grounds and all his/her exhibits and property have been removed.

**GROUP BOOTH/STALL:** Contracting parties for group stands are responsible for ensuring that all exhibitors within their group are fully aware of and have agreed to abide by these terms and conditions and by the rules and regulation of the exhibition.

**SUBLETTING OF BOOTH/STALL:** Exhibitors may not assign, sublet or portion all or any part of their booth space without the prior written approval of the organizer. The organizer reserves the right to charge additional fees to any exhibitor wishing to assign, sublet or apportion all or any part of his/her booth. The backwall of the stall should be compulsorily covered with branding or white flex.

**FORCE MAJEURE:** The organizer shall not be liable to the exhibitors by reason of any cancellation or part time opening of the exhibition either as a whole or in part, for any non performance of their obligations under this contract of or any amendments or alterations to all or any of the rules and regulations of the exhibition in each case to the extent that such occurrence is due to any circumstances not within their control.

**PROMOTION DURING THE EXHIBITION:** Exhibitors are reminded not to place sticker, signs or posters anywhere in the hall other than within their own stand. Likewise exhibitors representative (may not distribute brochures invitations etc.) along the gangways or near the entrance. This is unfair to other exhibitors and an inconvenience to visitors.

**UNFORESEEN OCCURRENCES:** In the event of any occurrence not foreseen in these Rules and Regulations, the decision of the organizer shall be final.

### SECURITY:

a) Exhibitors and their staff will not be allowed into the exhibition hall before or after the show hours. If your displays are very valuable and sensitive and you wish to hire security personnel to attend to your stand exclusively during off show hours, please contact the organizer for security services. Please note that you may not use personnel from any outside security agency.

b) All personnel in the exhibition halls must wear identification badges at all times. Exhibitors badges and contractor / service badges are available from the organizer's office at the venue.

c) For security and safety reasons exhibit movement in or out of the halls during off show hours is not permitted.

d) Our Security Agency will guard the exhibition site in general. But their duties will not include specific attention to any individual booths / stalls.

**PAYMENT TERMS AND CONDITIONS:** 100% advance payment should be cleared before the stall possession.

Exhibitors will not be allowed to occupy their space or booth / Stalls if the payment terms specified on the contract are not followed. These terms cannot be varied under any circumstances.

No refunds will be made on cancellations or reductions of booth / stall space.

**ELECTRICAL INSTALLATION:** All on-site electrical installations must be carried out by the officially appointed electrical contractor. All prefabricated electrical fittings will be subject to an inspection by the official contractor before connecting to the main supply. Payment for extra electrical load and consumption should be made to the organizers.

**EQUIPMENT INTERFERENCE:** No equipment can be operated which makes excessive noise or cause electrical interference or annoyance to other exhibitors. In this matter the decision of the organizer will be final.

**DAMAGE TO BOOTH / STALL:** No person under any circumstance shall cut into or through any floor covering or wall after any stand service structure except when authorized in writing by the organizer.

**BOOTH / STALL CLEANING:** During the exhibition days, the organizer will take care for the daily cleaning of the stall and gangways. During the build-up / dismantling periods independent contractors appointed by exhibitors are responsible for the removal of the stand building / dismantling materials and rubbish.

**ACCEPTANCE OF RULES:** The very fact that an exhibitor participates in the exhibition as an exhibitor, it will be presumed without any dispute that he/she and his/her company /organization has read the rules & regulations formulated by the organizer and as printed above and irrevocably confirm to abide by them. This is applicable to each and every participant irrespective of the amount or percentage of payment made to the organizer and includes participants, exhibitors / co-exhibitors as well as companies / organizations of complimentary booths / stalls, irrespective of the fact if they have signed or not signed the registration form or any other document.

Management has the right to change the dates of exhibition without prior notice in any circumstances.
